#### Career and Technical Education in North Carolina

At the secondary level, CTE is delivered through comprehensive high schools, CTE-focused high schools, career academies and STEM education and thematic schools, and early/middle college schools. At the postsecondary level, CTE is delivered through the state's community colleges.<sup>1</sup>


