

Career and Technical Education

Secondary CTE is delivered largely through comprehensive high schools and CTE centers, which are part of Career-Technical Planning Districts (CTPDs), as well as through community schools and career academies. Postsecondary CTE is delivered through the state's community colleges and adult workforce education centers.¹

Postsecondary CTE Participators, FY 2015²




In FY 2015, **41%** of secondary and **57%** of postsecondary students enrolled in CTE were economically disadvantaged.²


Career Clusters

Seven of the 16 career clusters in CTE lead to high-skill, high-wage, and high-demand STEM-related careers. These clusters include Agriculture, Architecture, Health, Information Technology, Manufacturing, STEM, and Transportation, Distribution, and Logistics and contain programs that prepare students for nontraditional careers.

Middle-Skill and STEM Jobs

The pipeline to middle-skill and STEM jobs loses young people at every level of the education system. Thus, the supply of sufficiently trained workers will not meet the demand of key industries.

Fast Facts

From 2014 to 2024...


- Computing jobs will grow by 17%.⁴
- Engineering jobs will grow by 6%.4
- Advanced manufacturing jobs will grow by 9%.⁴
- Of all job openings, 51% will require training at the middle skill-level.⁵

Yet...

- 22% of students who enter an associate's degree program graduate.⁴
- **58%** of students who enter a bachelor's degree program graduate.⁴
- 47% of workers are trained to the middle-skill level.⁵

Students pursuing careers in STEM, particularly computer science and engineering, must become academically prepared early in their educational trajectory.⁷



For Ohio, in 2016, college-bound female students earned an average math SAT score of **546**, compared to **582** for male students.⁸
